Church Point Landscape Committee Volunteers Needed

What does a Landscape Committee member do? They routinely check on landscaping in their assigned common area. They report problems with Common Area maintenance, grass, plants, trees, sprinklers and other upkeep to the committee Chairman or Select Group, Church Points' property manager. Then they follow up on resolution of those problems.

What do they NOT do? Weeds and high grass on resident's private property are NOT the responsibility of the Landscape Committee. The property manager, Select Group, normally takes reports from homeowners about this type of rules violations.

Another member from the Mews would be especially welcome. Someone familiar with Chesapeake Bay Preservation Area Regulations would be helpful for the waterfront park on Spring House Trail.

President's Corner

Dear Homeowners:

Summertime at Church Point is in full swing. Remember that our children are home all day, so please be extra careful as you drive around the neighborhood.

If you are planning major landscaping projects, home additions, pools, fences docks etc. you will need to submit an application for approval to the Architectural Control Committee (ACC) before you start your project. This will avoid a lot of potential problems as you go through the various city, state, Chesapeake Bay Authority, Army Corps of Engineers etc. wickets to obtain approval.

As most of you should know our landscape contractor Coastal has changed ownership. The Board of Directors (BOD) through our management company, Select, has been working with the new owner, who has been most cooperative, to ensure professional services are provided to our community.

In the last letter I addressed the Photenia issues along First Court Road. We have a draft amendment to our covenants from our attorney and intend to send a final draft with a recommendation from the BOD in the notice for the annual meeting. At that meeting and through a formal voting process, all homeowners will be asked to vote for or against the amendment for the HOA to assume responsibility to remove and replace the photenias and maintain the new plantings.

Neighborhood Watch – by LaTanya Cole

Let's talk about a type of crime that can affect all of us – IDENTITY THEFT. What is identity theft, how will you know if you are a victim, how can you protect yourself?

Identity theft is one of the fastest growing crimes in America. It occurs when someone takes and uses a person's identifying information such as their name, address, date of birth, SSN, etc. to commit fraud. If you become a victim, it will take time and money to clear your name and restore your credit standing. It is therefore easier to prevent identity theft than to recover from it.

You will know if you are a victim if your monthly credit card and bank statements suddenly stop arriving or if you are denied credit for no valid reason. Also if you start getting bills from companies that you do not recognize and collection agencies try to collect debts that are not yours, you may be a victim of identity theft.

In order to protect yourself you will need to consistently do these 7 steps:

1. Do not give out any financial information over the phone (home or cell), especially if you did not initiate the call.
2. Be careful of giving info out over the internet ("Big Brother" is watching!).
3. Do not put your SSN on your driver's license - ask for a DMV 'ID' number. Do not include your SSN or telephone number on checks nor put your telephone number, address, etc. on credit card slips when signing.
4. When paying bills, only include last 4 digits of your account number on the "for" line.
5. Monitor your credit file and order your (free) credit reports at least annually.
6. Shred (cross-cut) personal documents before placing in the trash, especially those pre-approved credit-card offers.
7. Finally, do not send bills from your home mailbox - drop at Post Office.

A future newsletter will include tips on what to do if, despite your best efforts, you are a victim of identity theft.
